Entry 51 of Annex XVII to Regulation (EC) No 1907/2006 is replaced by the following:

<p>“51.</p> <p>Bis(2-ethylhexyl) phthalate (DEHP) CAS No.: 117-81-7 EC No.: 204-211-0</p> <p>Dibutyl phthalate (DBP) CAS No.: 84-74-2 EC No.: 201-557-4</p> <p>Benzyl butyl phthalate (BBP) CAS No.: 85-68-7 EC No.: 201-622-7</p> <p>Diisobutyl phthalate (DIBP) CAS No.: 84-69-5 EC No.: 201-553-2</p>	<ol style="list-style-type: none"><li>1. Shall not be used as substances or in mixtures, in a concentration equal to or greater than 0,1% by weight of the plasticised material, in toys and childcare articles.</li><li>2. Shall not be placed on the market after <i>[OJ please insert date: 18 months after the date of entry into force]</i> in articles in a concentration, of one or more of the phthalates listed in column 1 of this entry, that is equal to or greater than 0,1% by weight of any plasticised material in the article.</li><li>3. Paragraph 2 shall not apply to:<ol style="list-style-type: none"><li>(a) articles exclusively for industrial or agricultural use, or for use exclusively in the open air, provided that no plasticised material comes into contact with human mucous membranes or prolonged contact with human skin;</li><li>(b) aircraft, or motor vehicles within the scope of Directive 2007/46/EEC, placed on the market before <i>[OJ please insert date – 60 months after the date of entry into force]</i>, or to articles, whenever placed on the market, for use exclusively in the maintenance or repair of those vehicles or aircraft;</li><li>(c) articles placed on the market before <i>[OJ please insert date: 18 months after the date of entry into force]</i>;</li><li>(d) measuring devices for laboratory use, or parts thereof;</li><li>(e) materials and articles intended to come into contact with food within the scope of Regulation (EC) No 1935/2004 or Commission Regulation (EC) No 10/2011(*);</li><li>(f) medical devices within the scope of Directives 90/385/EEC, 93/42/EEC or</li></ol></li></ol>

	<p>98/79/EC, or parts thereof;</p> <p>(g) electrical and electronic equipment within the scope of Directive 2011/65/EU;</p> <p>(h) the immediate packaging of medicinal products within the scope of Regulation (EC) No 726/2004, Directive 2001/82/EC or Directive 2001/83/EC.</p> <p>4. For the purposes of paragraphs 1, 2 and 3(a),</p> <p>(a) "plasticised material" means the following homogeneous materials:</p> <ul style="list-style-type: none"> <li>- polyvinyl chloride (PVC), other polymers such as polyvinylidene chloride (PVDC) and polyvinyl acetate (PVA), as well as any other plastics, except polyolefins,</li> <li>- rubber, except silicone rubber and natural latex coatings,</li> <li>- polyurethanes and any other foam rubber or foam plastic,</li> <li>- surface coatings, non-slip coatings, finishes, decals, printed designs,</li> <li>- adhesives, sealants, paints and inks.</li> </ul> <p>(b) "prolonged contact with human skin" means continuous contact of more than 10 minutes duration or intermittent contact over a period of 30 minutes, per day.</p> <p>(c) "childcare article" shall mean any product intended to facilitate sleep, relaxation, hygiene, the feeding of children or sucking on the part of children."</p> <p>5. For the purposes of paragraph 3(b), "aircraft" means one of the following:</p> <p>(a) a civil aircraft produced in accordance with a type certificate issued under Regulation (EU) No 216/2008 or with a design approval issued under the national regulations of a contracting State of the International Civil Aviation Organisation (ICAO), or for which a certificate of airworthiness has been issued by an ICAO contracting State under Annex 8 to the Convention on International Civil Aviation, signed on December 7, 1944, in Chicago;</p> <p>(b) a military aircraft.</p>
